



## **CHIEF NURSING OFFICER BROWNFIELD REGIONAL MEDICAL CENTER BROWNFIELD, TEXAS**

**Brownfield Regional Medical Center (BRMC)** is currently seeking a Chief Nursing Officer (CNO) to serve their facility located in Brownfield, Texas. BRMC is a rural community hospital and rural health clinic providing acute care to service the needs of the residents in Brownfield, Terry County and regional communities.

**The candidate should have advanced knowledge of nursing theories** and practices, well developed leadership and management abilities, including developing and managing a nursing budget. The ability to occasionally work alongside as well as work with staff to develop staff capabilities, competencies and confidence will be critically important for the successful candidate. Effective communication and interpersonal skills are an absolute must.

**BRMC is a 45-bed licensed full-service general medical and surgical hospital.** The Emergency Department is designated as a Level IV Trauma Center which provides care for patients suffering from a variety of injuries and illnesses. Nearly 6,000 citizens come each year to BRMC's Emergency Room, which is staffed 24 hours a day, seven days a week by Board Certified physicians. Other services offered include Obstetrics; Physical Therapy; 24/7 Radiology coverage which includes MRI, CT, Ultrasound and Bone Density. There is also the BRMC Clinic, BRMC Home Care and The Healthy Heart Center which offers a wide range of cardiac and pulmonary rehab, stress testing, and halter monitors.

**The successful candidate** will be a key member of the organization's leadership team, should possess 3 to 5 years prior experience as a CNO/DON in a rural/community hospital setting (other hospital management experience may be acceptable); possess a minimum of a Bachelor's degree in nursing (Master's degree in nursing is preferred). Nursing experience and/or supervisory experience in the following areas is desired: Med/Surg, OR, and ER. Candidate must be a Registered Nurse currently licensed by the State of Texas or ability to have compact license and must hold the following certificates: BLS, ACLS, PALS and CPR.

**Brownfield is 30 miles southwest of Lubbock, Texas,** 90 miles north of Midland, Texas, 170 miles northwest of Abilene, Texas and 70 miles northeast of Hobbs, New Mexico. The city of Brownfield is the county seat of Terry County, Texas. The county was created in 1876 and later organized in 1904. Brownfield, located on the South Plains of Texas, is at the junction of U.S. Highways 62, 82, 380, and 385 and State Highway 137. Brownfield and Terry County is The Wine Grape Capital of Texas.
